

# GENERAL SALES CONDITIONS

---

- 1.** Any booking implies acceptance of the campsite regulations and conditions below.
- 2.** Any reservation is personal and can not in any case be assigned or sublet. The kids aged under age 18 unaccompanied will not be accepted.
- 3.** The booking becomes effective only with the agreement of the campsite and after receiving a payment of 50 € for a location or 25% of the rental price. The booking request must be signed by you. Without written warning or phone from you, the location or rented accommodation becomes available 24 hours after the arrival date and the deposit is retained.
- 4.** No reduction will be made in case of late arrival or early departure. No reduction will be granted retrospectively, any reduction must be requested on arrival and upon presentation of the document only.
- 5.** For a pitch the balance of the stay and the tourist tax must be paid on arrival. For a rental, the balance of the stay and the tourist tax are to be paid one month before arrival.
- 6.** Any visitor to the day will be declared at the reception and must pay the going rate. The Domaine de Faurie reserves the right to refuse entry to anyone.
- 7. Sureties.** The sureties are required on arrival and returned or destroyed after your departure (except in case of damages observed by our cleaning crew).  
TARIFS: 30 € per power adapter. 180€ for the rented accommodation. 70€ for cleaning fee. 80 € for cleaning fee with pet. 50€ for fridge rental.
- 8. Cancellation.** In case of cancellation 60 days prior to arrival, the deposit will be refunded, less any term costs. Between 2 months and 1 month: the deposit is kept (25% of total price). Less than a month: 75% of the rental amount will be claimed (except upon presentation of a medical certificate). Without written warning or telephone location or rented accommodation becomes available 24 hours arrival date, after this period, it ceases to be retained and payments granted.
- 9. Cancellation and Interruption Insurance (Optional / Recommended),** we strongly recommend that you take out insurance for reimbursement of the costs of stay (according to the terms and conditions of insurance). This insurance is optional and represents 3% of the cost of the stay. In case of cancellation or interruption of stay, the responsibility of the campsite could not be committed. Therefore, it does not give rise to any reimbursement from the campsite. The insurance premium must be paid in full on booking the stay is non refundable. Cancellation and Interruption Insurance reimburses the full amount paid before the arrival of stay and the amount of unused prorated stay in case of early return (excluding handling fees and taxes). In case of loss, you must notify the Company within 5 days; the general conditions of complete cancellation are available on request or read online on our website and [www.campezcouvert.com](http://www.campezcouvert.com), [www.camping-lafaurie.com](http://www.camping-lafaurie.com).
- 10. Animals.** Only dogs and domestic cats on leash are allowed on the pitches at a daily fee. Only domestic dogs on a leash are allowed in rentals for a daily fee. You will then present their immunization cards at the reception. They should not be left alone locked up or in the absence of their masters who are civilly responsible. The rabies vaccination certificate is compulsory. "Tier dogs" and 2 nd categories are prohibited in the campsite. Access to health or pool there is strictly prohibited.
- 11. Fires;** The ground fires and fireworks, fireworks and firecrackers are strictly prohibited. Barbecues are allowed up (except in the wooded area), with the usual precautions, outside accommodation. (Fire extinguishers, water bucket, etc. ...).
- 12. Insurance.** It is up to the tenant to be insured for liability. The campsite declines all responsibility in case of fire theft, bad weather, etc. and in case of any incident concerning the civil responsibility of the tenant.
- 13. Rules of Procedure.** The rules are posted at the office. Anyone entering the site of the Estate must respect it. In case of breaking the rules of procedure, management or his representative reserves the right to remove without notice.
- 14. Image rights.** During your stay you will be photographed and your children or any person accompanying you registered the contract or visitors for animations and activities organized by the campsite for campsite communications needs. Please inform us in writing (This writing will be countersigned and conserved by the management) if you do not want to be photographed and appear on communication media of the campsite.
- 15. Mediation of consumer disputes:** Under the provisions of the Consumer Code regarding "the consumer dispute mediation process," the customer is entitled to use for free the mediation service offered by camping sarl domaine de la Faurie. The mediator "consumer law" thus proposed is MEDICYS. - 17. Absence of right to withdraw:** In accordance with article L.121-19 of the French consumer code, the campsite informs its customers that the sale of accommodation services provided on a specific date or in line with a specific timeframe is not subject to provisions regarding a withdrawal period.
- 18.
